As you know, your quarterly and annual statements are issued via post. We recently contacted you to let you know that you can now view and download your statements directly from the 'my wealth invest' app, as well our brand new web portal (see page 2 for more information).

Printing and posting statements can take time, so a digital statement may be available much earlier than a paper version.



How to access your digital statement

- 1. Click on the main menu, in the top right corner of the screen.
- 2. Select the 'documents' section.
- 3. Your most recent valuation statement will be at the top of the list.

Your preferences

If you have the app and/or new web portal, your preferences will be automatically set to receive paperless statements.

To carry on receiving paper statements, you can update your preferences in the app or web portal. Click on the main menu, select 'preferences' and toggle the paperless setting off.

If you don't have the app or new web portal, you will continue to receive paper statements.
